Legislation

It's been an incredible year and we could not have gotten this far without you, our committed supporters. We've laid a great foundation at the capitol and are excited to keep up the momentum through the summer and into next year's legislative session. Y'all deserve some serious kudos! Oregon's GRA joint volunteer efforts between the IIDA Oregon Chapter, the ASID Oregon Chapter, and the IDC-Oregon lobbying coalition continue to reach out to allies, opposition, and legislators to educate Oregon's citizens on the importance of commercial interior design licensing. The IIDA Oregon Chapter Board alongside the coalition representatives has formed a powerful and successful alliance this past year. Oregon's efforts are gaining some serious interest on the national level as a model of success for other states to mimic.

IDC-Oregon worked diligently to push House Bill 2491 out of committee and to the house floor. While a formal House hearing on the bill was not scheduled, we were granted an informational hearing with the Business and Labor Committee on April 25, 2011. It was a huge success for qualified interior design professionals to educate legislators on the differences between commercial interior design and other forms of the practice within the industry.

HB2491 is now under revision. We've made enormous progress contributing towards next year's legislation efforts. In addition to hearing from over 200 interior designers in support of a Practice Act, we have also heard from legislators how to make our bill language more clear and stronger dispelling many myths the opposition presented to our fellow representatives.

Nationally, on May 6, 2011 another victory for GRA activities was announced conjointly in a press release by IIDA and ASID out of Chicago, IL. The United States Court of Appeals 11th Circuit unanimously affirmed a

2010 district court decision to uphold Florida's interior design statute. The Florida Senate defeated H.B. 5005, the "Deregulating of Professions and Occupations" bill, by a vote of 32-6. The Senate's decision to uphold the 2010 decision by Judge Robert Hinkle [because] it "promotes compliance with fire and accessibility codes, helps reduce indoor pollution, and protects consumers."

The Fine Art of Unemployment

Hopefully the worst of the layoffs are past and the need for this article will have lessened. Just to be safe, I wanted to offer some suggestions to those of you who are unemployed to help you along the way. Even if you are gainfully employed there may be some useful tidbits for you as well!

the punch

I was shocked at the array of emotions I felt in the wake of my layoff. After being loaned out to a different organization, working 40–70 hours a week for the previous several months and being literally 18 hours away from a month-long vacation, the layoff came as a bit of a shock. Even when somewhat expected, the reality of a layoff still stings. For me, there were feelings of worthlessness, loneliness, shame, embarrassment, and slight panic, just to name a few. Very typical emotions, from what I've been told.

Fortunately for me, I was active in other areas and my self-worth and general happiness didn't revolve solely on my career. That *did* make those feelings easier to deal with and I was able to move forward quickly. Staying positive is very important. Regardless of your current employment situation, it's good to be reminded of a simple truth: *you are not your job*. Even those who are able to make a living doing what they love are more than the sum of their career.

before the blow

Prepare Yourself!

- Don't put your medical needs on the back burner. Waiting until you are laid off to refill those prescrip-

tions and receive your annual checkups & dental exams should be avoided. Instead of panicking to make all those appointments while still insured, you can use that time to research health insurance and examine your options. Although your options may be limited by things like pre-existing conditions, you won't be able to make the best choice without doing your homework. Blindly choosing an available COBRA plan can seem easier, but it may not be your best bet.

- Keep track of your projects: ask for the marketing sheets and whatever other information will make updating your portfolio easier. Do this as the projects close-out to avoid that last second scramble!

after the hit

Educate yourself!

- Familiarize yourself with how the unemployment department works and how benefits are calculated. Take some time to read their literature. If you have questions, give them a call. It's important to understand how working part time and/or contract work can change what benefits you will receive weekly and in the future. Check with them about training opportunities. Is there a skill that would make you more marketable that you didn't have time to learn before?
- 401k / retirement plans: This is not a topic which I am qualified to give any specific advice, but you should know your options when/if you part ways with your employer. Talk to your HR person as well as a representative from the investment company.

Stay Connected!

- Keep in touch! Make sure that you keep in contact with all your friends at other firms and your own firm. This may be awkward at first, but once you get past that initial weirdness the connections are great!
- Contact the reps! Make sure they have your personal email address on their lists so that you can stay involved in the activities and education they offer. They are often the first to know when firms or other businesses are hiring. Assuming you've maintained a great relationship with them over the years and they will think of you when they are asked for recommendations depending on fit.

Reach out!

- People still working in the industry aren't the only ones worth staying connected to. There may be other people in your firm or other firms that you know who were laid off. Contact them, see how they are doing. Make some new connections. Check in on that lonely old lady down the street or that crotchety old man and help yourself by helping others.

Free Time!

- The obvious! Update your resume and portfolio. A word from experience: keep current backed up copies of all the info you use. An online resource is best but an external hard drive is also a good option. Keep the drive in a separate location. I found out the hard way; all of my portfolio information was lost when my computer was stolen.
- Volunteer! Find an organization that you are interested in and see what you can do to help out! IIDA Oregon is looking for board members for the 2011 - 2012 board year now! A chair position is a great way to start!
- Make a list! Remember all those things you've wanted to do but never did because you were too busy with work? You know, the art project, the deep clean, home improvement, personal development, and those types of things? Write them all down and get organized! Break them down into simple steps and make a specific plan for when and how you'll do them.

- Exercise! It's a great way to fight off boredom, depression and fat!
- Take a class! Community colleges offer very affordable courses. Take something you've always been interested in or something that will further your knowledge in your career. Research other local organizations that also might have something to offer. For example, Mercy Corp offers business development courses and has scholarships available if you meet the criteria.

finances

Eeek! This is a major problem for a lot of unemployed people. It may be that drastic changes are in order just to get by. Chances are you will have to adjust your spending. I suggest making a detailed list of all your expenses, and then dividing them into needs and wants. There will be some hard choices to make. Things like cable, gym memberships, and spendy cell phone plans may have seemed like needs at one time, but they might have just become wants. Don't be afraid to ask someone ask someone else for some subjective money saving ideas! There are tons of online resources to help you look at your spending, needs and wants from a different point of view.

recovery

Things may never be as they were pre-crash, but I'm hoping that we all find our way back to prosperity. This may look differently to each of us. Happiness doesn't always come with a degree and a fancy title. The tide has changed, alternative work weeks, telecommuting, and many other non-traditional opportunities arise where there were just 9-5 jobs. Take this time to look at what you really want out of life, what's really important to you and make a new plan! It may not feel like it at times, but you are in control of your future!
